## I. PURPOSE OF THE REPORT

- 1. The purpose of this report is to:
  - i. Update the Court with respect to the receivership; and,
  - ii. Request that this Honourable Court approve the:
    - a) Proposed distribution to the secured creditors in order of priority;
    - Receiver's activities and fees incurred to date, plus the estimated fees, disbursements and taxes to a maximum of \$15,000 to complete the administration of the receivership;
    - c) Fees of the Receiver's legal counsel to date plus the estimated fees, disbursements and taxes to a maximum of \$7,000 to complete the administration of the receivership; and.
    - d) Discharge of the Receiver, subject to the distribution of funds on hand in accordance with an Order of the Court.
- This is our Final Report to Court and should be read in conjunction with the First Report to Court dated October 20, 2023 (the "First Report").
- In preparing this Final Report and in making recommendations to the Court, the Receiver has been provided with and has relied upon information obtained from discussions with the director of Beyond the Grape on Premise Winemaking Ltd. ("BTG" or the "Company") and from a review of the Company's books and records. The Receiver expresses no opinion or other assurance in respect of the accuracy or completeness of such information as is reflected in the Receiver's Reports to the Court.

# II. BACKGROUND

- 4. BDO Canada Limited was appointed as Receiver (the "Receiver") of the assets, undertakings and properties (the "Assets") of the Company pursuant to an Order made by the Supreme Court of British Columbia on September 18, 2023 (the "Court Order").
- 5. Pursuant to another Order in the Supreme Court of British Columbia issued on September 18, 2023, BDO Canada Limited was also appointed as Trustee (the "Trustee") in the Bankruptcy of Beyond the Grape on Premise Winemaking Ltd. Attached as Appendix A is a copy of the Bankruptcy Order.
- 6. In the First Report dated October 20, 2023, the Receiver outlined to the Court the purchase offers received. The Receiver accepted an offer (the "Asset Purchase Agreement") from Chris Walton and Ian MacKerricher (the "Purchasers") for \$201,013. The Asset Purchase Agreement was subsequently amended to assign it to Train Wreck Brewing Ltd., a newly incorporated company for which Chris Walton and Ian MacKerricher are the directors. The Asset Purchase Agreement was approved by the Court on November 3, 2023 and closed on November 21, 2023.
- All of the Assets have been sold as part of the receivership proceedings.

# III. SUMMARY OF RECEIVER'S ACTIVITIES

- 8. Since the date of the Receivership Order, the Receiver's activities have included:
  - a) Performing its statutory duties as required pursuant to subsection 245 (1) and 246(1) of the Bankruptcy and Insolvency Act, RSC 1985, c B-3 (the "BIA") in relation to creditor and Official Receiver notification;
  - b) Freezing the Company's bank account;
  - c) Attending the Company's premises in Port Moody, British Columbia and securing the Assets;

- d) Arranging for a custodian to monitor the leased premises and Assets;
- e) Contacting the Company's landlord and making arrangements to continue to occupy the leased premises during the receivership;
- f) Working with the former principal to obtain additional information with respect to Assets of the Company;
- g) Borrowed \$50,000 in Receiver's borrowings from BDC to cover ongoing costs;
- h) Reviewing the Company's existing insurance coverage and determining the appropriateness thereof;
- i) Soliciting auction proposals with respect to the Company's Assets;
- j) Canvassing other local breweries to determine the level of interest in purchasing the Assets;
- k) Reviewing auction proposals and offers for the Assets;
- I) Obtaining Court approval for the sale of the Assets;
- m) Working with Canada Revenue Agency ("CRA") to facilitate a payroll trust audit;
- n) Liaising with numerous creditors;
- Attending to discussions and correspondence with legal counsel and various stakeholders;
- p) Initiating the transfer of the liquor licenses;
- q) Disclaiming the lease for the premises on November 21, 2023;
- r) Filing applicable statutory returns;

- s) Remitting payments to priority creditors:
- t) Providing updates to BDC and RBC; and,
- u) Preparing two reports to Court.

# IV. DISTRIBUTION TO CREDITORS

- 9. CRA conducted a payroll trust examination. The result of the examination was a property claim of \$18,839 owing to CRA for unremitted payroll source deductions. The Receiver has remitted the balance owing on the property claim to CRA as of the date of this report.
- 10. Employees were owed approximately \$3,000 as a result of unpaid wages prior to the receivership. The Receiver has remitted the balance owing on outstanding wages to the employees as of the date of this report.
- 11. Business Development Bank of Canada ("BDC") is owed approximately \$752,000 by BTG. Royal Bank of Canada ("RBC") is owed approximately \$408,000. Both parties hold general securities agreements in respect of all present and after-acquired property of BTG. RBC and BDC signed a priority agreement dated August 28, 2019, which gives BDC priority over select pieces of equipment, and RBC has first priority over the remaining Assets.
- 12. The Receiver reviewed the B.C. Personal Property Registry ("PPR") in respect the Company and confirmed registration of the security interests of RBC and BDC. The Receiver is not aware of any other remaining claims that may be in priority to RBC and BDC. Attached as Appendix B is a copy of the PPR search conducted on May 29, 2024.

- 13. The Asset Purchase Agreement's purchase price was for \$201,013. The purchaser assigned a value of \$182,013 to the property over which BDC has priority. The remaining \$19,000 was assigned to the property over which RBC has priority. Accordingly, BDC will be paid approximately \$43,000 and RBC will be paid approximately \$4,500.
- 14. Accordingly, the total distribution to creditors is estimated as follows:

15. Both RBC and BDC will suffer significant shortfalls on their respective claims.

Accordingly, there is no recovery for unsecured creditors.

18. For the period of July 25, 2023, to October 31, 2023, a summary of the Receiver's fees and disbursements were:

- 20. Copies of the Receiver's invoices referenced above are provided in Affidavit #1 of Chris Bowra sworn on May 29, 2024.
- 21. The secured creditors have reviewed and approved the Receiver's invoices.

## Receiver's Staffing and Hours

22. Chris Bowra had primary responsibility for the work carried out by the Receiver. Where appropriate, this work was delegated to other staff. A summary of the time spent on this assignment by members of BDO Canada Limited for the period beginning from our involvement on July 25, 2023 to October 31, 2023 is summarized below.

- 23. In the Receiver's opinion, the time and disbursements incurred in the course of its duties are:
  - i. comparable to receivership assignments of similar scale and complexity; and
  - ii. necessary in order for the Receiver to fulfil its obligations.
- 24. The hourly rates charged by the Receiver are:
  - consistent with the hourly rates billed by the Receiver on other engagements; and,
  - ii. consistent with other insolvency firms of comparable size engaged on similar receivership matters to the Receiver's knowledge in the Province of British Columbia.

25. The Receiver requests that the Court approve the Receiver's fees and costs incurred to date of \$57,184 and additional fees and costs to a maximum of \$15,000 to complete the administration of the receivership.

### **Summary of Legal Fees**

26. The Receiver engaged McMillan Dubo Law Group ("MDLG") as its independent legal counsel. The total fees of MDLG were \$17,075 and disbursements of \$499 as summarized below.

- 27. Attached as **Appendix E** is a summary of McMillan Dubo Law Group's invoices for the period September 15, 2023 to November 30, 2023. Details of MLDG's fees and invoices are attached as Exhibit "B" to the 1<sup>st</sup> affidavit of C. Bowra filed in this action.
- 28. The Receiver has reviewed the invoices of MDLG and believes them to be proper and reasonable. The legal services provided were necessary for the Receiver to fulfil its obligations.
- 29. The Receiver also engaged Gehlen Dabbs Cash LLP ("GDC") to confirm that BDC's security was valid and enforceable as against the Trustee. GDC's fees were \$2,007, and disbursements, taxes and other charges of \$493.
- 30. The Receiver requests that the Court summarily approve the legal fees of MDLG and GDC incurred to date and approve additional fees, disbursements, and taxes for MDLG to a maximum of \$7,000 to complete the administration of the receivership.

## VII. CONCLUSION AND RECOMMENDATION

#### Conclusion

- 31. The Court approved the sale of the Assets on November 3, 2023.
- 32. The sale closed on November 21, 2023.
- 33. The secured creditors will suffer significant shortfalls on their respective loans. There will be no recovery for unsecured creditors.

#### Recommendation

- 34. The Receiver respectfully requests the Court approve the:
  - Payment of the balance of funds to the secured creditors of approximately \$43,000 to BDC and \$4,500 to RBC;
  - ii. Activities and the accounts of the Receiver and its legal counsel;
  - iii. Additional Receiver's fees, disbursements and taxes to a maximum of \$15,000 to complete the administration of the estate;
  - iv. Additional fees, disbursements and taxes of the Receiver's legal counsel to a maximum of \$7,000 to complete the administration of the estate; and,
  - v. Discharge the Receiver on the terms set out in the proposed form of Discharge Order appended to the Receiver's Notice of Application filed concurrently with this report.


